MESSAGE FROM REV. HACKBARTH

Michael, a willing servant of Christ Jesus by the will of God, for the sake of the promise of life that is in Christ Jesus, to my fellow brothers and sisters in this community of Christ: Grace, mercy and peace from God the Father, and Jesus Christ our Lord.

I always like the way Paul (the Apostle) began his letters by identifying himself, his recipients, and then concluding with a salutation (usually "grace and peace"). Being an admirer of St. Paul I want this to be as Pauline-like as I can make it.

I imagine that there are a few of you that remember the winter of 1959. Do you remember the heavy snowfalls that closed schools, stopped trains and forced people to wrap chains



around their car tires so they could get around? I remember that winter because that is when I wished for an "Eskimo" jacket for Christmas. Any traveler will tell you that a hood is far superior to a hat in snowy weather.

I remember walking through Taylor Park (in Fond du Lac) on my way home from school and it was the last day of school before Christmas vacation (yes-it was actually called that back then). As I walked through the swimming pool area I was ambushed by a gang of high school thugs (they were three times taller than me and threw snowballs that seemed like basketballs) and in minutes I was filled with snow and ice. I made it home, all the wile pleading to God for an Eskimo jacket to be under the tree on Christmas morning.

When I entered the house my mother met me at the back door, not to hear my complaints but to tell me to hurry inside and listen. My younger brother, Mark, was sitting on the floor in front of the Nativity Scene singing "Happy Birthday" to the baby Jesus. At first I was not impressed since I had more practical things on my mind, yet my brother's impromptu singing did bring me back to reality – Christmas is about Christ.

At the heart of Christmas is the "good news of a great joy" spoken of by the angel in Luke 2. "For today in the city of David there has been born for you a Savior, who is Christ, the Lord." Christmas is so sacred because it observes the birth of a Savior. Not just any Savior. A Savior who is the long-awaited Messiah and a Savior who is the Lord God Himself! God has visited his people to save them. The little babe in the feeding trough is Immanuel (God with us).

Many people today think they need to be saved from political oppressions, a bad economy, gender bias, political incorrectness, social inequality. So many today feel "victimized" by a hundred things, but not the one thing that has truly victimized them: **sin.** Matthew 1:21: "and you shall call His name Jesus, for He will save His people from their sins." Jesus did save us 33 years later by bearing our sins on the cross.

Christmas is good news to those who know all too well the weight of their sinfulness. This news is a great joy to those who feel guilty and unworthy of God's love, and are afraid of His punishment. In a sense, Christmas is only for such people. For them it is a celebration of God's complete forgiveness and unconditional love through the Savior, Jesus Christ.

"Fear not," said the angel to Zacharias. "Fear not," said the angel to Mary. "Fear not," said the angel to Joseph. "Fear not," said the angel to the shepherds. There seems to be a pattern here!

Fear is something Zacharias, Mary and Joseph experienced when standing in the presence of the holy. What about us in this "new" millennium? It seems that we are more often afraid of the secular than the sacred, but we are afraid, just the same.

If you are struggling with fear this Christmas season, then listen to the words of the angel. "Fear not!" God says to you through him. Christ has been born so "that we, being delivered from the hands of our enemies, might serve Him without fear, in holiness and righteousness before Him, all the days of our life" (Luke 1:74-75).



It doesn't take too long to find out that with all the planning and work that went into the new Respite Center that just maybe we might have forgotten something. Yep, we did. This past year we found out that in severe weather our kids would be without electricity in the shelter at the new Respite Center. Thus, our Respite campers and their caregivers would be without light, water and toilet facilities. However, due to the wonderful and benevolent members we have in this great state, we were able to get a 45 kw generator installed at a price of \$12,000.00. A big atta-boy goes out to those suppliers and installers who donated their time and/or money to complete this important and necessary project in time for the summer camping schedule. The dedication of the new generator took place on Elks Day last June. I am proud to say that we had 100% participation of all Lodges in the state.

Ken Saville, Easter Seals, has informed me that the new facility has greatly increased their ability to help additional campers and it has definitely relieved the overcrowding that they were experiencing before we built the new center. The facility has been filled to capacity every camping week.

Back in June 2009, we made our third payment of \$60,000.00 to East Seals towards our loan. Our balance is now \$120,000.00. (Just two more payments remaining.)

We are now beginning to turn our sites toward the expansion and remodeling of the Elks Lodge (dining hall) to help the kitchen staff with the overcrowding at meal times. Next spring we will be forming a committee made up of our Major Project Building Board Committee and maybe a couple of members who might be interested in helping our committee. Our goal is to be able to start the new project as soon as possible after we make our final loan payment on the Respite Center. Just think, since 1994 we have invested almost \$2,000,000.00 toward Camp Wawbeek. WOW!!!

Your **"Exalted Rulers March"** is your Lodge's day to shine and it will again be held at the **Mid-Winter Conference in Stevens Point**. We will be holding the **March on Saturday right after the Association Luncheon**. A special photo session with our respite camper guests will take place immediately after each Exalted Ruler or representative presents his/her Lodge's check(s).

Just a reminder that you can still purchase a brick for "Pave the Way for Respite Care". Be a part of the permanent patio at the Respite Center by buying a brick and having your own special message engraved on it! Remember your donation is tax deductible. See a committee member to get a donation form.

Also, I wish to extend a big **THANK YOU** to all sub-committee chairpersons and their committees for the fine work that they have done to make all our programs a success.

Working with computers and your Lodge's Virtual Home Page is the main topic for the Mid-Winter Conference. This session will cover the basics for beginners. We will also be on hand to answer any other questions you may have.

Our Area 5 Grand Lodge Public Relations Committeeman, Art Hutton, will also be on hand to answer questions about the Lodge Reporting Form and the Grand Lodge Public Relation Contests. Please join me in welcoming Art and his wife Katy. Art is a member of Fairfield Lodge #1192, from Fairfield, IA.

By the time you receive the Mid-Winter Bugle, each Lodge should have received a letter from me with instructions on how to appoint a Cyber Assistant, if they do not already have one. The fee is \$25 per year; since there are only two months left of the Lodge year at Mid-Winter, Grand Lodge will not charge your Lodge the fee for these 2 months. This will allow you the time to work with your Lodge page and to see if this is something you would like to continue if your Lodge doesn't work with the home page.

Either the Secretary or the Exalted Ruler appoints the Cyber Assistant by filling out a form with Grand Lodge. To be appointed as a Cyber Assistant you must first sign up as a user on the Grand Lodge Site. This temporary access will only be valid until April 1st, at which time the new Exalted Ruler or Lodge Secretary may appoint you again. The Lodge Secretary already has rights to edit your Lodge's Virtual Home Page.

If you are the Secretary, the Cyber Assistant, or are just interested in learning what is available on the Grand Lodge Website please attend the session.

Please bring a picture of your Lodge, event pictures, newsletters, calendar of events; all must be in digital format either on a flash drive or on a disk. We will show you how to crop, upload and change.

If you have a laptop with wireless connectivity, please bring that as well.

1) Lodge competition:

- Milwaukee is the only Lodge to send an application for the competition.
- Team will perform at 2:30 PM.

2) 11 O' Clock toast:

- Saturday morning 9:00 AM 12:00 PM (Place to be announced)
 - Whenever a person is available, they can sign up and perform. There will NOT be a set time for anyone.
- If desired, the performing member may bring in another member to give the charge to.
- 3 Categories:
 - ER's Only, Open (for <u>any</u> Elk member), DDGER vs. Vice Presidents vs. PSP's
 - Once someone wins in any category, they are allowed to "defend" their title.
 - DDGER vs. Vice Presidents vs. PSP's:
 - They will be considered, in the open category, but the highest performing DDGER's, VP's or PSP's, will receive a plaque.
 <u>ALL</u> are <u>EXPECTED</u> to perform, even if someone won in the competition before.
 - The President is part of the Vice President's group and the Special Deputy Grand Exalted Ruler will be part of the DDGER's.

3) Individual positions (ER, Leading Knight, Loyal Knight, Lecturing Knight, Esquire and Chaplain):

- Time of competition: 9:00 AM 12:00 PM
 - This will coincide with the 11 O' Clock toast.
 - Again, there is not a set time to perform.
 Whenever someone is available, they can sign up and perform.

RULES FOR NEW RITUAL COMPETITION AT MID-WINTER CONFERENCE

- 1. Positions and parts that will be judged:
 - a) Exalted Ruler

The charge given to the candidate, when the ER is at his/her station and the candidate is at the Alter, up until the time the three raps are given (The raps will not be done, but the two questions have to be spoken, with no response, unless a member is brought in as a candidate).

b) Esquire

The charge given to the candidate when the Esquire is half way between the candidate and the Esquire's chair.

c) Chaplain

Prayer given at the Alter

d) Lecturing Knight

Charge given to the candidate, when the candidate is at the station.

e) Loyal Knight

Charge given to the candidate, when the candidate is at the station.

f) Leading Knight

Charge given to the candidate, when the candidate is at the station.

- 2) The parts will be judged on impressiveness, pronunciation and word accuracy.
 - Just like the 11 O' Clock Toast.
 - The Esquire part is the only position to be judged on deportment (hailing sign, wave of the hand, salute to the flag and the voting sign)
- 3) The competition is open to <u>any</u> member in good standing.
- 4) A member can do any part they desire:
 - Once a member wins a position, they are allowed to "defend" their title.
- A member who has won a position, at an actual State Ritual Team Competition, is not

allowed to do that position.

- If a member will be performing in the team competition, they are not allowed to perform their part, in the individual competition.
- 5) A member can do more than one position.
- 6) If desired, the performing member may bring in another member to give the charge to.
