## STATE CHAPLAIN'S MESSAGE

When all Israel saw that the king refused to listen to them, they answered the king: "What share do we have in David, what part in Jesse's son? To your tents, O Israel! Look after your own house, O David!"

So the Israelites went home. 1 Kings 12:16 NIV

A leader cannot connect with people when he is communicating among groups; he must connect with individuals. The stronger the relationship and connection between individuals, the more likely the follower will help the leader. Successful leaders always initiate, they take the first step and make the effort to continue building relationships.



Connecting with people is not complicated but it takes effort. Take a look at the truths that Rehoboam (son of David) ignored:

- 1. One's people are more willing to take action when they are first moved by emotion.
- 2. If the leader gives first, their followers will give in return.
- 3. By connecting with individuals, one gains the attention of crowds.
- 4. When a leader reaches out to the people, the people will reach back.
- 5. Whether one has "taken over" a leadership position or one is well established, one *must* connect with the people in order to succeed.

I learned these time-honored tenets of small unit leadership early in my military career. What is surprising is that these constructs of leadership change very little regardless of the size of the organization. If one fails at any of the above stated constructs, one's leadership position is compromised.

In order for any organization to grow, the ability to develop meaningful individual relationships will help insure a healthy environment for corporate growth. People will respond to leaders that show their sincerity and willingness to communicate and share the hard work.

It seems to me that the Wisconsin Elks Association has many leaders that demonstrate many of the tenets referenced above. Perhaps with a little more personal communication within our respective Lodges, we might see more people willing to "reach back" and follow.

#### EAST CENTRAL DISTRICT

Wow... where has the time gone? The holidays have come and gone, and another year is in the books. I sincerely hope your holidays were safe and happy. I know mine were both joyous and busy. I realized after I received my last copy of the Bugle that I had missed the deadline for article submission, so the East-Central District didn't have a DD Report last time.

What an amazing year we have had so far. I was inspired by the great work in the communities that the Lodges in the East Central District showed me at all of my visitations. It looks to me like all of the Lodges are doing a great job promoting the work of Elkdom. Way to go! I am greatly impressed to see that the East Central District, as of the writing of this article, stands at \$10.56 per capita in donations to the Elks National Foundation. Not only has the District as a whole more than doubled the Grand Exalted Ruler's goal, but each Lodge in the District has individually surpassed the goal. When was the last time we could say that? What makes our District even better in the eyes of the ENF is that five out of the six Lodges are in the top 10 in the state in per capita giving, and from that, three of the Lodges are in the top five in the state in per capita giving. One of our Lodges has even made it all the way to number three in the nation in the ENF Chairman's Challenge scores. It's exciting to see that in these tough economic times, the East Central District is giving all they can to show that Elks Care, Elks Share.

However, I would be remiss if I didn't speak about the one thing that has been proving the greatest challenge in recent years




