## REVEREND HACKBARTH'S MESSAGE

"---and the star they had seen when it rose went ahead of them until it stopped over the place where the child was. <sup>10</sup> When they saw the star, they were overjoyed. <sup>11</sup> On coming to the house, they saw the child with his mother Mary, and they bowed down and worshiped him." Matthew 2: 9-11 NIV



It seems that my earliest memories of Christmas are about the decorating of the tree. My brothers and I were too young to decorate the tree with the lights, ornaments, and tinsel; yet we all begged to have the privilege of placing the star at the top of the tree. Whomever won that honor was lifted up by Dad and placed the star (as securely as possible) on the tree.

We waited anxiously for Dad to plug the cord into the wall – what a grand and glorious sight – the lights blazing – the glittering of the tinsel – and the glowing of the star!

My brothers and I sat in front of that tree relishing its splendor, and always gazing at the star.

Dad gave me this star recently, still in its original box (ca. 1950) labeled "Tree Topper." My memory of that "tree topper" was that it was always bright. smooth, and glossy in appearance (at least that is how I remembered it). Looking at the device, I was astonished at how its appearance had changed. The glossy patina was no more, the smooth surface was pock marked with numerous dents, and staples held the seams together. It seems that my father's frugal nature of "never-ending repair" extended itself to Christmas ornaments too. Perhaps he viewed the star as a necessary symbol that needed to be maintained.

Jesus' birthday has always carried many symbols such as the manger, swaddling cloths, shepherds, sheep, donkey's, angel choirs, wise-men (from the East), just to name a few. Yet one cannot forget the appearance of the star.

That mysterious star was the sign of great importance to those astrologers, and it functioned as the directional guide to Jesus' location. After the men found the "newly born king," this celestial beacon vanished from sight – but not from our collective memory.

Somehow, in my mind, this old family relic (star) resembles the Church in our current secular world. church still is a symbol and tool of God's purpose to redeem humankind. She (the universal Church) began as a shining symbol of redemption for millions of people, yet through the 20 centuries of its existence has gone through many changes and has had numerous repairs (theological staples). For many people the church's patina has dulled and Jesus' birth has become more of а season of excessive materialism and less than one of hope for redemption.

It seems to me that our lives appear to be reflected by that little star. We were nurtured in the "love and knowledge" of Jesus Christ, yet through the years we have been battered by multi-culturalism, materialism, and numerous other "isms." Through all of this we are continuously drawn back to Jesus and repaired (stapled), and sometimes to have those staples burst and (through God's grace) new ones applied. Through all of this, we retain the hope for redemption through God's radiant gift, Jesus.

I will affix my family heirloom to my Christmas tree this year (without my Dad's help) and it will shine for another decade or two until I pass it on to one of my daughters. This year I will see it as I believe it to be - a sign of great importance, a reflection of God's love for his creation and an everlasting guide for our hope of redemption.

This article will have a different message than previous articles written for *The Bugle.* Ken Johnson, State Secretary/Editor of



Bugle suggested that submitting an article enclose a picture of themselves so that members can put a face to the writer. He also thought that it would be an enlightenment for anyone that doesn't know what the Elks are or what they do. Hopefully, the articles written could be used as a collective account to help bring in new members and, perhaps enlighten present members to something they did not know and maybe rededicate their caring for Elkdom.

As a reminder for all of us that have been an Elk for many years and those new members recently initiated, the Elks are a fraternal organization that was organized on February 16, 1868. The Elks are made up of American citizens (men and women) of the United States and its territories with a membership of over a million individuals.

The Benevolent and Protective Order of Elks are dedicated to serving communities in many areas of Americanism, drug awareness, scholarships, veteran and youth sports, to name just a few examples of what Elks promote.

A little history lesson that many may not know: the Elks colors are royal purple and white. The white denotes purity and absolute truth, while the royal purple color signifies the love of truth and the highest degree of virtue.

Purple is the color for the robes of emperors and signify highest favor. The blending of white and purple indicated the favor of the people which bespeaks of the status of Elkdom. In addition to the Elk Organization colors, each state has its own color, and our is in Wisconsin is red. Some Wisconsin Elk history that you may or may not know is:

- -- The first formal State Convention was held in June 1902 in Oshkosh at which time there were 28 Lodges.
- -- In 1920 the Grand Lodge Headquarters were in Dubuque, Iowa.
- -- The Milwaukee Lodge hosted the Grand Lodge Convention in 1933, the last time it would be held in Wisconsin.
- -- The Grand Lodge in 1930 converted our two districts, East and West, into a third district configuration, which became the Northeast, Northwest and South Districts. This arrangement would last until 1961, when change occurred again.
- -- In 1989 the Grand Lodge reorganized Wisconsin from four to six districts in order to reduce travel time for its District Deputies. Central and East Central Districts were created with the stroke of a pen and the Northeast District lost 40% of its members and four of its most active Lodges.
- -- The first state Elks public Flag Day Ceremony was held in Kenosha on June 14, 1935.

- -- The circus baron, Al Ringling's mansion became home to the Baraboo Elks in 1936.
- -- In 1937 our State Association established its first scholarship contests and awards.
- -- 1956 was the year the first reference of a donation of \$1,000 to Camp Wawbeek.
- -- In 1965 Wisconsin Elks had its first Constitution Contest and in 1974 had its first National Hoop Shoot winner, a boy from Kaukauna.
- -- In May 1994 the State Association changed the direction of its Major Project, starting a Respite Care facility in Pioneer Camp at Wawbeek.
- -- In 1995 the Grand Lodge Session allowed women to become Elks.

These are some facts gleamed from the Wisconsin Elks 100 Years 1902-2002 Book. I hope those facts enlighten both long time Elks and those who may be thinking of joining our Benevolent Protective Order of Elks.

The Mid-Winter Wisconsin Elks Conference in Madison, February 3<sup>rd</sup> - 6<sup>th</sup> will soon be here! It is a time when we Elks can relish in our accomplishments as well as face the challenges in our local Lodges to serve our communities and help our State and National Associations continue our charitable programs. Maybe together we can make a little history of our own.




#### TWO RIVERS ELKS PRESENT BLUE STAR BANNERS

This past June our Elks Village Respite Center has been operating for four years and has served 854 campers this year, more than any year in the past. Next June we will make our final loan payment to Easter Seals of \$60,000.00 and will then move on to our new project of expansion and remodeling of the Elks Lodge dining hall. With the increase in campers the dining hall is overcrowded at mealtime.

We are in the process of forming a new Building Board Committee for the dining room expansion so if anyone would like to be on the committee please contact me. We will hold our first meeting this spring.

At the Fall Conference I reported that the roof on the first Respite Cabin was in bad shape and needed to be replaced before winter and I requested that each Lodge contribute \$200 so we could accomplish this with the help of a donation from Easter Seals and the balance a loan from Easter Seals. I have taken the role of State Youth Activities Committee Chair. 

#### ARE YOU BEING SHORT CHANGED?

The Committee for the Disabled can help your Lodge. When your Lodge helps the disabled, whether it's equipment or financial, your Lodge may qualify for reimbursement. Take care in not short changing your Lodge. When in doubt, file a claim. Meetings are at 9am on Saturday at State Conventions and State Conferences.

#### GUILDINES FOR PAYMENT AND FILING CLAIMS

- 1. Lodge claims for projects involving a specific person will be figured at a rate of 50% up to \$1000 per project.
- 2. Lodge claims that are not going to a specific person will be at maximum rate of 50% up to \$1000 per project per year. Example school for the disabled, disabled work projects or group outings and activities.
- 3. Claims received for the last meeting of the budget year will take preference over any claims submitted by any Lodge that has received more than 25% of the committee's budget.
- 4. All claims must be for current year and received no later than Mid-Winter Conference.
- 5. No claims for funding going for research of diseases. Example: cancer, heart, or aids.
- 6. No claims for transportation, food or clothing for volunteers.
- 7. Lodge cannot profit from any activities sponsored by their Lodge. Cost of goods can be submitted. Example: food and beverage.
- 8. Lodges are to investigate the worthiness of the project and fund the project before filing a claim. All claims must be accompanied with proof of payment.
- 9. A representative MUST BE PRESENT to present the application during the Committee for the Disabled meeting, otherwise no action will be taken
- 10. All claims for the committee's consideration MUST BE IN THE CHAIRMAN'S HAND TWO WEEKS BEFORE THE MEETING.
- 11. Each Lodge is allowed to request one campership claim per year, unless at the end of the Mid-Winter meeting there remains unallocated funds. At that time additional campership claims will be considered and equal payment applied.
