24	MR. JOHNSON: Mr. President, Ken
25	Johnson, Wausau 248, makes a motion to approve them

2	the website.
3	MR. SHANNON: Miron, "Ron," Shannon,
4	Beaver Dam 1540, seconds.
5	MR. DEMMIN: Okay. We had a motion and
6	a second.
7	Any other discussion?
8	(No response.)
9	MR. DEMMIN: All in favor, signify by
10	the use of a voting sign of an Elk. Hands up.
11	Hands down.
12	Opposed, same sign.
13	Motion is carried.
14	I now recognize Jan Schultz,
15	chairperson of the Credentials and Elections
16	committee for her preliminary report.
17	MR. JOHNSON: He dropped the mike
18	(inaudible) able to talk into it.
19	MS. SCHULTZ: Jan Schultz, Marshfield
20	Lodge No. 665.
21	We have issued a total of 203 voting
22	credentials.
23	Procedure for voting will be given from
24	the podium. A total of 225 Elks are in attendance at

this convention. That's three more than last spring.

2	And that is all I have until the next
3	time.
4	MR. DEMMIN: Thank you, Jan.
5	We will now proceed directly to the
6	election process.
7	I now recognize Rob Radig, Senior, Past
8	State President, State Parliamentarian, to explain
9	the nomination and elections procedures.
10	MR. RADIG: Rob Radig, Beaver Dam Lodge
11	1540, State Parliamentarian.
12	Good afternoon, ladies and gentlemen.
13	ALL: Good afternoon.
14	MR. RADIG: Oh, well. The bylaws of
15	the Wisconsin Elks Association provide for the
16	election of officers at this convention, which is one
17	of the most important decisions that we will make
18	each year as we elect new leadership and reject
19	inject renewed enthusiasm into our association.
20	Regarding offices, all Elks in good
21	standing in this association are eligible to hold
22	office with the exception of the offices of President
23	and President-Elect. These offices may only be held
24	by a Past Exalted Ruler.
25	Nominations are to be made from the

_	rioor for all elective offices. With respect to the
2	office of Vice President, they are nominated and
3	elected only from their corresponding Grand Lodge
4	district. Vote only for the candidates nominated
5	within your district.
6	Trustees are selected, one trustee from
7	each Grand Lodge district. Today we are selecting
8	the trustees from two districts, the Northwest and
9	the Northeast districts. I remind you that the
10	Trustee positions are voted on by the entire
11	delegation. So no matter what district you're in,
12	you vote for the Trustee in all all districts.
13	This year, we are also elect (verbatim)
14	a Secretary, which is a two-year term.
15	Please submit a clear ballot. You need
16	to indicate if you're voting for one of the contested
17	positions by only writing one name. If you do not
18	submit a clean ballot, the Elections committee is
19	going to have to declare the ballot invalid. So make
20	sure your vote is clear on your ballot.
21	If there are more than two candidates
22	for any position, after balloting, if no candidate
23	receives a majority of the votes cast, a runoff
24	election for all for the office shall immediately
25	be conducted, the voting being on the two candidates

1	receiving the largest number of votes on the first
2	ballot. In order for a runoff to be avoided, a
3	candidate must receive 50 percent plus one or, as I
4	indicated, a majority.
5	This year, we have two announced
6	candidates for President-Elect. So unless a third
7	candidate is nominated on the floor, a runoff will be
8	unnecessary.
9	In the case of a runoff, please do not
10	leave the room after the first ballot. If you choose
11	to leave, you will not be permitted to return.
12	At the conclusion of my instructions,
13	the President will call upon Jan Schultz, chair of
14	the committee on Credentials and Elections to
15	supervise and conduct the election and collect and
16	count the ballots.
17	As we've done in past years, the
18	committee will have members stationed around the
19	room. When you have completed your ballot, please
20	proceed to the nearest committee member, present your
21	ballot, along with your voting credential.
22	After the ballots have been collected,
23	the regular business of the convention may proceed
24	until the committee is ready to report the results of
25	the election.

1	If at any time of completing the
2	nominations where there is one candidate for any one
3	office, the President may direct the casting of a
4	unanimous ballot for such candidates.
5	Upon completion of the count, the
6	committee shall report the results of the election by
7	reporting the number of votes cast for each candidate
8	for office.
9	Finally, I propose the following rules
10	for nomination and seconding speeches. For
11	President-Elect, one nomination speech of not more
12	than three minutes, two seconding speeches of not
13	more than one minute. For Trustees, Vice Presidents,
14	and all other offices, one nomination speech of no
15	more than one minute and one seconding speech of no
16	more than one minute. In all cases, seconding
17	speeches are optional.
18	Mr. President, I move for the adoption
19	of these rules for nominations.
20	MR. DEMMIN: Thank you, Rob.
21	Is there a second to that nomination?
22	MR. SHANNON: Miron, "Ron," Shannon,
23	Beaver Dam 1540, seconds.
24	MR. DEMMIN: Is there any discussion?
25	(No response.)

6	I, once again, recognize Jan Schultz

10	Lodge 665.
11	You will be turning in a green ballot
12	clearly marked as to who you want to elect and your
13	credential. Do not tear off anything that will be
14	done by the committee members.
15	Also, if there is a contested race for
16	any of the VPs, turn in that ballot also.
17	That's all I have until the next round.
18	MR. DEMMIN: Thank you, Jan.
19	Now, at this part, while you guys are
20	deciding is when we have our chairman of the board of
21	directors come in to give a presentation of the
22	budget that everybody should have.
23	Huh?
24	MR. JOHNSON: Yep. Looking for
25	DeRosier.

3	Where is Mr. DeRosier?
4	MR. JOHNSON: I know Dave said he had
5	to run upstairs quick so
6	All else fails, I'll do it myself.
7	MR. DEMMIN: Should we start with the
8	elections then?
9	MR. JOHNSON: Nope. We start with the
10	administrative. Just hang on with me.
11	MR. DEMMIN: Yep.
12	We're going to do something else.
13	UNIDENTIFIED SPEAKER: Okay.

15	MR. JOHNSON: I'll move that back and
16	forth here so you can hear me.
17	But Ken Johnson, Wausau 248, presenting
18	the administrative budget that was adopted by the
19	board of directors yesterday. You do have this in
20	front of you.
21	I will highlight, on the bottom, we're
22	carrying over from last year to this year \$1,511.00.
23	Last year, you noticed we carried over 11,000. So
24	there's a \$10,000 shortage from last year to this
25	year.

T	The number right below that is 43,698.
2	That's the money that we have actually collected in
3	dues this year from the membership. That gives us
4	that working capital, which is not quite going to
5	make it.
6	It was the recommendation and adopted
7	that we would take \$20,000 out of our Raymond James.
8	And on a side note, I've kind of been pushing this
9	for a few years because our predecessors have always
10	said, let's not touch that money and save it for a
11	rainy day. I'm kind of afraid some day we're not
12	going to be here, and it's going to be raining like
13	mad. So starting to use it.
14	One of the things we're using it for,
15	if you can notice there
16	David, you're up over here when I'm
17	done talking, please.
18	When we took and increased the BOD
19	amount by \$3,000 Gina Staskal from Government
20	Affairs has had a request for Government Affairs for
21	a fund of about \$3,000. That money was moved into
22	the Trustees' contingency fund. So it is there when
23	she makes the presentation to the board of directors
24	of getting that money allotted to her to do what
25	the proposal she had asked for, as I'm looking at he:

1	jumping up and down a little.
2	Also, then you can see some of them
3	were just modest in increases. Mailings go up.
4	Office expenses go up, et cetera.
5	Now, the one that you're going to see
6	is under Conferences and Conventions. That has gone
7	up by \$6,000 \$6,100. A hundred dollars was for
8	overhead. The \$6,000 is put aside to be used by
9	direction with the board of directors to again, to
10	help offset some of the expenses of conferences and
11	conventions, mainly the meal cost, to help more
12	members attend these things and see the things that
13	are going on and just return some of it to those that
14	are here.
15	So at this time, to get it on the
16	floor, I'm going to I'm going to move, Mr.
17	President, that we adopt the administrative budget
18	for 2019-2020, which is a balanced budget of
19	65,209.16.
20	MR. DEROSIER: Dave DeRosier, Milwaukee
21	Lodge 46, second this for discussion.
22	MR. DEMMIN: Okay. We have a motion
23	and second. Any discussion?
24	(No response.)
25	MR. DEMMIN: Hearing none, stand as

20	money carried over from the charitable side because
21	charitable money should be spent. End of discussion.
2	So to carry it over, we had 8,890 8,879.

5	screen that is the bottom numbers there.

1	Now, in and outs. From the National
2	Veteran's Service, you've got 22,080. That matches
3	evenly with the top number of 22,080 that comes from
4	Grand Lodge. You'll see in our State Projects Grants
5	from Grand Lodge, you're going to have 112,140.
6	State Charities, 84,840. Bonus grants, 16,740. From
7	our Benevolent Fund, a hundred thousand. A money
8	market carryover of 355 350,351.19.
9	Now, with that extra and the carryover,
10	we're coming in at around 11-, \$12,000 more income
11	with the carryover from last year. The board decided
12	to kind of split that money and share it amongst
13	Drug Awareness did ask for about a thousand dollars
14	more. They did get it. Elks Major Project, they
15	asked for more, but they got 45,000 in the budget,
16	which is 3,000 or 4,000 from last year. The

21	but they always made sure they took care of Camp
22	Wawbeek, took care of our campers, and made sure that
23	respite was and continues to be one of the finest

25	The Elks are magnificent with their

1	support of camperships.
2	So again, Ray is one of those real
3	solid people. Been on the committee for a long time.
4	He's the one, I think, that really helped us maneuver
5	over some rough times and smoothed out all of our
6	relationship with the Elks and and kept up with
7	the wonderful tradition we have here at camp.
8	UNIDENTIFIED SPEAKER: When you come to
9	the camp and see what it has done for the caregivers
10	and the letters and cards that I receive and that the
11	association receives from the caregivers, that they
12	can appreciate what we have done.
13	They drop their child off at this camp
14	for one day, three days, five days, or a week. And
15	they can spend more time with their other children or
16	simply just spend time together instead of having to
17	take care of their child 24/7. I can't imagine how
18	difficult that is sometimes, especially when a family
19	has two children with either cerebral palsy, autism,
20	spina bifida, whatever the case may be. This is what
21	we are here to do.
