

It is Normally A funtime, we get to meet a lot of good elks who come by the table to purchase tickets and Gab, and it's a really great way to meet new friends.



Our Lodges continue to initiate new members to grow their membership while working on those that have yet to renew. Very proud to announce Madison 410 has initiated over 50 members so far this Elk year. The biggest thing I see all Lodges need to do to grow their membership is to not only put that membership application in the prospects hands, but hand them that pen as well to fill out on the spot.

Overall our Lodges continue to be active not only within their Lodge, but their communities as well. Milwaukee 46 continues to support the Senior Lunch Program, hold a weekly Friday Fish Fry, as well as an All You Can Eat Broasted Chicken and Pizza Dinner on the first Wednesday of each month. We have also seen Milwaukee raise funds for the War Dogs and honor MPD District #4 for National Law Enforcement Awareness Day.

Janesville 254 continues to focus on their Live Music events and raffles to bring in funds to support their community. Already this year, Janesville has been able to donate over \$20,000 to assist their community and youth. Janesville also held their annual Deer Fest and held a Sportsman's Banquet.

Plateville 1460 will be holding their annual Pasty Fundraiser in March. Along with their fundraisers, Plateville has been able to donate towards Badger Camp and the Plateville Holiday Project. And our great friends at Beloit 864 continue to use their grants to support their community and vets with donations to Defy Domestic Violence Shelter, Gift Men's Shelter and Housing4OurVets. Plus Beloit will be celebrating a dedicated member's 104th Birthday and 71 years of service as an Elk.

Finally Waukesha 400 has been continuing their work with raising funds for the community in support of those affected by the tragic events that took place at their Holiday Parade. Waukesha's Veterans Committee recently raised and donated \$2000 to Waukesha South High School Band to help replace instruments. The Lodge has also provided space to the Guardian of the Children and Modern Woodsman to hold a fundraiser for the Dancing Grannies, and coming up will also be donating space and a meal for the Waukesha Xtreme Dance Team for their end of season banquet. Current Waukesha has even donated \$3,000 to various local school programs to assist our youth including funds to support the purchase of new robots for a schools First Lego League Robotics Program. And we can't forget that Waukesha will also be installing their first female Exalted Ruler and has also celebrated 75 years of a member's dedicated Elk service.

As I said, I have been honored to represent this district and I look forward to seeing how our Lodges continue to grow and overcome adversity in this time of need. Also proud to say every Lodge in the South District surpassed the GER \$4.80 per member ENF donation by Midwinter Conference.

I read about all the good things going on in our communities and ask myself "If not the Elks, who would pick up the slack and help our fellow man like we do?" What an honor it is for me to serve our communities and represent our members.

Space does not allow me to expound on all the good works of the Central District, I shall instead summarize those that have caught my eye:

Baraboo: continues to grow in membership and they are getting a large group of reinstatements which shows that people are coming back as they see the good works of the Elks organization. Our monthly basket raffle program is beyond any expectations where members donate a major gift and we raffle the basket. To date over \$3000 has been awarded to local charities.. Three of four ENF grants have been awarded with the fourth grant in process for the 2022 Prom for Special Needs in heavy planning. Our 104th Annual Kids Christmas program was great with over 100 local children attending.

Beaver Dam: Donated \$300 to Dodge County Canine Program. Used grant monies to Joes House for Sober Living, Veterans homeless transitioning' and PAVE projects. Assembled and distributed 300 Christmas food baskets.

Neenah/Menasha: Adopt a family donation of over \$500 to a single mother and special needs son. They are supporters of two Scout programs. Currently, they are in the process of providing grant money to parks for handicap swings for local parks, awaiting approval from local authorities. Recycle plastics to TREK for new park benches.

Oshkosh: Still supporting Sleep in Heavenly Peace, a bed building program which supplies beds for those in need. They continue to host calendar and meat raffles. They delivered 208 Christmas baskets to those in need. Working hard to recruit new members and working on lodge improvements.

Portage: Portage continues to work hard on membership and reinstatements. Food baskets delivered on December 18th. Bar Olympics planned for March 12th with proceeds to Elks charities. Super bowl and euchre tournaments were held in February. Portage Elks had a float in the Portage Christmas Parade.

Sheboygan: Our largest chapter in the Central district continues to recuit new members and has a lapsation of only 4 members Community activities include Salvation bell ringing, Coats for Kids, Hoop Shoot, and Adopt a Family, and Scholarships. Weekly Friday specials, bowling, pub night, and weekly pizza nights help engage members. Improvements include new windows in bar and lighting around exterior.

Watertown: Watertown Elks continue to support Heros Cafe to increase awareness and participation. They have a Bean Bag league and Sheepshead on Tuesdays .Family game night and wild game feed planned. Watertown is working very hard on membership and lapsation. Continue to work on building improvements..

These events I've recognized don't even cover all of the good work that go unmentioned in each lodge. I am so proud of the Central District and truly honored to represent all of you. It is truly a privilege and an honor to work with all of you on our mission as Elks. Your kindness to me and Kathy is so appreciated. We are truly blessed to be a part of this great organization. 




