It's a great day to be an Elk!

Can you believe it? We are already more than halfway through the 2023/24 year.

It has been an amazing and humbling experience serving you as your State President.

Six months ago, I set seven goals for the state, so let take a look at how we are doing so far with the goals.

1. ENF— Each Lodge to reach the Grand Exalted Ruler's Goal and a state total of at least \$110,000. Total donations are \$67,625.52. We are approximately two-thirds of the way toward the state goal of \$110,000. Becoming a member of the Fidelity Club is simple! Enroll online at: enf.elks.org/recurring and start your gift today!

- **2. Benevolent Fund** Raise a state total of \$27,700 (\$3.90 per person) –I understand that most of the lodges wait until the ER march to turn in the Benevolent Funds to the State, but we are currently only at \$6,255.55 or \$.91 per member.
- **3. State Project** Increase attendance at the three Elks events at Camp: Camp cleanup, Elks Day, and Pancake breakfast. We have had an amazing turn out at all 3 camp events including nearly 60 Elks in attendance for the camp's annual pancake fundraiser!
- 4. Conferences and Convention Increase attendance at both conferences and convention including the Saturday night banquet and Sunday morning General sessions. Attendance at conferences and convention continues to grow and so does the creative ideas and programs to help all members to work as a team.
- **5.** Calendar Create a WEA google calendar, including all state, and lodge



events. The calendar is a huge hit and a wealth of information on all things related to the Wisconsin Elks.

6. Committees – Have each Committee create a 1-2 paragraph description of what their committee does and post the description on Facebook. This will help promote conference and convention attendance. Many of the state committees sent me a nice

description and hopefully a few more will follow.

7. Membership - Have a membership increase of at least 40 members.

We have lots of work to do for a membership increase. We currently are projected to have a loss for the year of 367 members. We have 68 candidates who are waiting to become Elks and a whopping 500 unpaid members.

I encourage every lodge to host a few 50/50 raffles and put the profits toward the state's three major charities. ENF, Benevolent fund, and the State Major Project.

Remember the road to success may be both hilly and full of curves, but if you stay on the path, you will eventually get to where you want to go.

A message from the State Sponsor


Greetings everyone,


From your president elect

Lead with the Law of Connection

Then Paul stood in the midst of the Areopagus and said, "Men of Athens, I perceive that in all things you are very religious; for as I was passing through and considering the objects of your worship, I even found an altar with this inscription:

TO THE UNKNOWN GOD. Therefore, the One whom you worship without knowing, Him I proclaim to you. Acts 17: 22-23

In the four sermons that Luke records in the book of Acts, Peter, Stephen, and Paul all practiced the Law of Connection, which states that leaders touch a heart before they ask for a hand. Paul's sermon recorders in Acts 17 are a masterpiece with respect to this law. He connected brilliantly with people from a different culture, showing that he understood both Greek society and human needs.

Notice how a master communicator connected with his audience:

He began with affirmation.

He bridged his subjects with the familiar.

He enlarged their vision of God.

He used inclusive language.

He gave them encouragement and hope.

He identified with some of their own poets.

He gave them specific action steps.

Only when Paul had built relational bridges with the people, did he issue a clear call to repent.

It seems to me that we all have the ability to learn from a master communicator such as Paul. Many of the communication constructs itemized above can go a long way



in our daily life. If one is holding a leadership position in an Elks lodge; many of the constructs listed above may help in activating people to work on a special project.

I'm sure that we all understand our respective community's culture; yet how well do we relate our customs with someone that has transferred from another lodge? Do we *affirm* their presence in

the lodge, search for familiar topics, use inclusive language, and give them encouragement and hope? When that new person accepts a task or leadership position in the lodge, are they given specific action steps?

I believe such things are probably done to some level by key personnel. Yet are all of our members aware of the constructs of the Law of Connection when meeting a new member? It seems to me that affirming a person's presence, familiarizing them with a new culture and giving them encouragement and hope will help solidify one's commitment to the lodge and unify our membership.

Remember, God loves you, and so do I.

Elks' history – 'Hello Bill!' origins

How many of you have signed into elks.org/members and have seen "Hello, Bill!" (or Billie!) has been a traditional, friendly greeting among Elks since 1897. Visit our online membership directory to connect with your fellow Elks or click one of the profiles below to send a friendly, "Hello, Bill!" greeting to a new friend? You probably wondered what that is all about since my name is Jerry (or your name). Here is the reason.

ORIGIN OF 'HELLO, BILL!'

WILLIAM GODDARD, of Minneapolis (Minn.) Lodge, No. 44, B. P. O. Elks, is the original "Hello Bill!" of Elkdom, and this cheerful salutation which has found its way around the world, originated in Minneapolis during the Elks' National Re-Union in that city in 1897. Brother Goddard is the junior partner of the Minneapolis firm of Barnaby & Company. He has been for a great many years the treasurer of Minneapolis Lodge, No. 44, B. P. O. Elks, and was Chairman of the Finance Committee, and a member of a great many other committees that had in charge the arrangements for the Elks' Re-Union of that year, and he spent a great deal of his time at the Committee headquarters.

When visiting Elks came to the headquarters to inquire about matters, they wanted to know about, if they happened to meet anybody who was not fully posted, they were usually told to "Go over there and ask Billy Goddard," and it was a constant strain of "Billy can tell you," "See Billy, he knows," etc., etc. This was repeated so incessantly that the stranger Elks, when they approached Brother Goddard, greeted him with the expression, "Hello Bill! I was told to see you," etc., and so the custom started of greeting each other "Hello Bill!"


In a day or two the custom spread to the streets, with Elks from all parts of the country, and passing each other they sang out cheerfully, "Hello Bill!" and they carried the greeting back to their home lodges, and so it has spread around the ends of the earth.



The lodge holds a monthly cookout for the Elks National Foundation. Janesville Lodge #254 hosted a Fall Sportsman's Elks Charities Banquet on Oct. 20. Nov. 3, Janesville hosted a Charity Halloween Costume Party and dinner event with live music (benefiting Wisconsin Vest-A-Dog Organization). A Smoke & Barrel II Charity event was held Nov. 4 as a fundraiser for "Shop with a Cop."

Madison #410: Elks held a Blood Drive with the Red Cross Sept. 6. Madison #410 currently has 760 Elks members

representing the largest membership count in Wisconsin. Oct. 4, Madison Elks participated in the Easter Seals Pancake Breakfast at Camp Wawbeek. Madison Lodge #410 participated in the Orton Park Festival Aug. 25-27, and Sessions at McPike Park Aug. 11, 12, 16, and 17. The Madison Elks Lodge will again sponsor the Toys for Tots charitable program (in 2022 \$5,000 in gifts & cash was raised by members).

Waukesha #400: Elks hosted a third annual Car Show event generating funds for the Waukesha K-9 police unit (\$13,000 has been raised in 2 years). Oct. 31, Lodge #400 held a Trick or Treat evening with Elroy the Elk and provided sweet treats for neighborhood children. Waukesha Lodge #400 has been awarded three grants this fall: Spotlight Grant (being used for "Friends with Food" pantry program), Beacon Grant (being used to host Breakfast with Santa on Nov. 25 with a focus on homeless families inmWaukesha), and Gratitude Grant (being used to host another Senior Swing Dance on Nov. 17 admission is free).

Platteville #1460: Elks provided Grant presentations to Ruby's Pantry, Platteville's Farmer's Market Nutrition Program, Southwest Opportunity, The Hodan Center, Platteville's and Cassville's Food Pantries. Platteville Elks participated in the annual Dairy Days Parade with the Elks Trailor being pulled along the route. Platteville presented a part of their Beacon Grant donation to Sleep in Heavenly Peace (\$2,000). They held a brat and hotdog fundraiser on Oct. 28. Lodge #1460 used their Spotlight Grant to host a Community Baby Shower with free baby supply giveaway at the Platteville Public Library Oct. 21.

Milwaukee #46 provides a monthly \$100 give away for Teenager of the Month under Youth Activities. A total of \$545 was raised for Elk Charities by Linda's Ladies through

basket raffles at the Elks Family Picnic. Milwaukee #46 presented a check for \$565 to Brown Deer Middle / High School for their Special Education Program. A chili cookoff fundraiser for the Lodge was held Oct. 28 to generate funds for lodge expenses. The Milwaukee Lodge is now eligible for an additional \$500 to next year's Gratitude Grant due to donations of their members by helping in the ENF National Chair Challenge. Milwaukee helped generate \$1,500 in fundraising by contributing 26 bottles to the Benevolent Fundraiser at the WEA Fall Conference.

I want to again commend the efforts of our South District Lodges as Elkdom continues to impact the communities, people, and charities we serve.

In the last few months, Beaver Dam #1540 was officially merged with Watertown #666 by Grand Lodge to form the new Watertown-Beaver Dam Lodge #666. This merger will allow the new Lodge to serve both communities with combined resources, while still allowing for their individual programs to continue and thrive.

As we navigate the winter and the holiday season, we all as Elks do some really good things in our communities. We hold Hoop Shoots to show our youth the value of fair competition and good sportsmanship; we remember our veterans who fought bravely to assure us the daily freedoms that we can so easily take for granted; we reach out to help those less fortunate to have a better holiday season by delivering food and supplies, holding Breakfast with Santa events, and the list goes on and on. Soon, we will be awarding scholarships to the bright scholars in our communities who will go on to be the leaders of tomorrow. Just thinking about all the good we do should bring you a great feeling of holiday cheer.

As we move forward, the Central District is again a shining star for the Elks National Foundation. We've surpassed the GER's goal of \$4.80 per member as a District, and every Lodge has also individually passed that goal as well. On top of that, during October, the ENF announced a new \$500 bonus for the Gratitude Grant. If your Lodge increases your fundraising by 10%, you get even more free money. This means that your Gratitude Grant can be worth up to \$4,000 by getting all the bonuses.

As we move into the later months of our Elks year, we cannot begin to rest on membership. At the end of October, our District was projected to finish the year with a plus-27 for membership (although this number might be skewed slightly due to the merger of Beaver Dam and Watertown).

We had already initiated 68 new members and reinstated 7 more, but we also had 60 delinquents. Two-thirds of our Lodges had double digit delinquencies. While finishing +27 sounds like a good number on the surface, can you imagine what it will look like if we're able to get all of those delinquent members to pay their dues and continue working with us? If you haven't done so already, make sure to reach out personally to each of your delinquent members. Instead of asking them to immediately write a check, ask them why they've let their membership go delinquent. You might want to consider reaching out through a personal and heartfelt email instead of cornering them or cold-calling them, and remind them of all the good things we do as Elks. This will allow the member time to collect their thoughts and formulate a response, especially if they are going through some difficult times or have valid reasons for not renewing their membership.

Small personal touches can make all the difference. But, as we all work diligently to reduce our lapsation, we must also not forget about our candidates in waiting. Do everything you can to initiate your candidates as quickly as possible so that they can join in the great work that we do.

If we work hard at recruiting quality Elks and reducing our lapsation, we might just finish the year with a +100 in membership for our District. Once you initiate new members, make sure to welcome them, get them engaged, and get them involved. The worst thing you can do is tell a new member that you don't need their help when they ask. Turning away an enthused member will only hurt you in the long run.

It's rather difficult to talk about doing more when our District already does so much.

I wanted to take the time to write about a personal experience that I had at our recent Fall Conference in which the words "Elks Care" have never had so much meaning to me, and had such an impact on me.

On Saturday, Sept. 16 while we were volunteering in the hospitality room prior to the Elks dinner banquet I noticed my wife Sarah receiving a phone call from my sister Linda who lives in San Antonio, Texas. I was surprised and a bit apprehensive at first but assumed that the call may have been a misdial by my sister; I was trying to make eye contact with my wife Sarah to gain insight on the conversation she was having. Sarah's glance to me during the call was reassuring, calm, and controlled. Ron and Nikki Shannon who were socializing with us at the time of the phone call and could sense the concern that was building in me, they too were reassuring as the phone call ended.

Sarah already knew the urgency I had regarding the call and we walked into the hallway outside the hospitality room where she relayed my sister's message. I was told that my father's health had rapidly declined and his immediate prognosis was grave; I was urged by family members to travel to Texas as soon as possible to be with him during his final days. I was obviously stunned by the news and felt that I was not mentally registering the significance of what was now taking place at our home in Kingsville, Texas.

Sarah in her concern for me asked if I felt we should leave the conference to make arrangements for my flight to Texas to be with family. I was feeling unsure and overwhelmed at that moment, but decided we should just keep the information on my father's health private and should carry-on with the evening's event and then leave directly after Sunday's General Session. We dressed for the evening banquet, and

decided we would honor my father in quiet silence for the remainder of the conference.

As the banquet was getting started and people were settling into their seats, my mind began to think back over the years with my father and our special moments together. I told my wife that I was getting a bit emotional and wanted to excuse myself from the table to compose my feelings. While walking out of the room I noticed Rev. Michael Hackbarth standing on his own and was compelled to ask him for a few minutes of his time. Rev. Mike kindly asked me to join him in the chapel room where he had given his evening prayer service earlier that afternoon. Rev. Hackbarth and I began to speak and I told him the dire news on my father that I had been given only a short time ago. He took my hands in his and provided words of prayer, comfort, and compassion for me, my father, and all those in my family. Rev. Mike gave me peace and strength to carry on in that moment; I felt an incredible feeling of warmth, and a sense of calm came over me as I knew everything was going to be just fine.

As word of my father's condition began to spread among our Elks family, Sarah and I were met with such a genuine expression of CARE from Elk members, officers, and from dignitaries who provided words of comfort and encouragement to us. I will never forget the outpouring of kindness, prayers, support, and love shown to me and for my extended family.

I have full faith and confidence knowing that at that moment when I received the difficult news about my father, that I was predestined to be with my Elks family at the conference; God knew I would be in good hands of those who truly CARE.

I was blessed to be at my father's side when he peacefully passed away on Friday, Sept. 29 at 92 years of age.

The State Major Project Committee is pleased to have as our guests, Kate Thomas and her family for the Mid-Winter Conference Banquet. Kate's mother, Laura, has provided the following very personal perspective on what the Elks/Easter Seals Respite Camp means to not only Kate, but the entire family.

As Wisconsin Elks, we should all be very proud of our contributions to a program that touches the lives of families who need and deeply appreciate our support. (See their photo on the cover).

Thomas Family shares their story

Tim and I were married in 2001, and life brought us to Reedsburg, Wisconsin, as we pursued job opportunities in the area. Little did we know how much this community would come to mean to us, and how ideally situated it was going to be in the future.

In 2003 our son Hayden was born, shortly followed by Joshua in 2004. Our daughter Grace was born in 2009 and we welcomed twin daughters Emily and Kate in 2011. While we never really discussed how large a family we hoped for, we feel blessed to call these five amazing kiddos our own.

A twin pregnancy introduces different reasons for monitoring. Our girls were going to be named Emily Lauren and Katherine Eileen. We call her Kate or Katie. And, she had a secret. During the ultrasound, it was determined that Kate would be born with a congenital heart

defect. More importantly, the type of heart defect pointed to the strong assumption that Kate was going to be a person with Down syndrome.

We focused on what was going to be needed to fix Kate's heart. Even before she was born, we met the team of providers who knew the plan – and more importantly gave us all the reasons to remain hopeful.

Kate's heart was fixed at AFCH when she was 3 months old. We still celebrate every Dec. 14 as "Heart Day" because of what is means to our family.

We are very lucky. Kate's heart repair was the main medical hurdle we needed to cross. And we know That for many families that is not always the case. Kate dealt with some typical struggles. Ear infections and sinus infections plagued her for many years. But now as a 12-year-old middle schooler, it takes a lot to keep her down.

A special needs parent might tell you that often there is a need to experience tremendous grief in order to fully appreciate unbelievable joy. We grieved Kate's diagnosis, simply because it was different than expected. We were uncertain how it would impact her sibling relationships, and what decisions we might need to make professionally.

In time, Tim and I

have learned to not get caught up in the future "what ifs?" and instead stay in the moment. One beautiful aspect of life with Kate is that the pace is slower. Meeting Kate's needs causes one to shift perspective or priority and allows us to truly understand



what is means to celebrate each accomplishment. There truly is unbelievable joy found in everyday moments.

The sibling relationships we worried about are instead some of the strongest bonds we

will ever encounter. Siblings help hold each other accountable. The way Kate's brothers and sisters expect her to carry her own weight around the house is exactly what she needs to help her become as independent as possible. And now that they are older and better understand how to connect with



Kate, there is a willingness to meet her where she needs them. They too are learning how to celebrate everyday moments with her. They are her fiercest defenders and we no longer about the future knowing they will be there for Kate.

In a busy family, Kate understands that her siblings are involved in many extracurricular activities. She is their loudest cheerleader. She's sat in the stands at many basketball games, and on the sidelines for many tennis matches. When Kate was able to start swimming lessons, we were so excited for her. Swimming is one of Kate's favorite activities – other than bowling. This year she gets to participate in Special Olympics.

But if there is anything that Kate loves the most....it is going to Easter Seals camp. For the past few years, Kate has attended either respite weekends or summer week-long sessions. The first time we brought her to camp, Kate looked at me and said "Mom, you can go now."

She just knew this was going to be fun and it was all for HER. Camp allows her to meet

new friends, demonstrate her independence, try new things, and sing her heart out during the talent show. Camp offers what she hopes for each time she attends. And when she comes home the change is obvious. She

> reminds us "I can do it myself" and we remind ourselves not to hover.

The joy that Kate experiences when we pull into the camp parking lot, and as we drive away, brings tears to our eyes every time. Seeing her happy is all e hope for, and the camp opportunities through Easter Seals makes this possible.

One aspect of camp is what it does for Kate. But there is a very real reason

why the word respite is used in the description. The other aspect is what camp does for us. Sometimes, being a special needs parent and family means you carry a "backpack" of worries around all day. You may not realize how heavy it gets, because you just keep moving forward. But when someone gives you the opportunity to take off that "backpack", you realize how you different you feel. You don't need a lot of time but just enough to feel the "weight" shifted.

When Kate attends camp, we and her siblings get that opportunity to recharge – both physically and mentally. And we've learned to accept these camp opportunities knowing that it is both rewarding for Kate and us all at the same time. Walking into the registration hall means walking into a room of people who all understand. There is no need to explain. It's truly an opportunity to exhale and connect with others who are on the same journey.

Trust looks different when you have a child who may not be able to fully advocate

for themselves. The team at Easter Seals takes this trust relationship very seriously and we have every confidence that Kate is well cared for while at camp.

When we came to Reedsburg, we had no idea that just a few miles away in the Wi Dells would be this camp that would come to mean so much to us. We're just a few years in, but we look forward knowing that Kate will have this opportunity as an adult too. We remain grateful for the support of others who make camp possible, either through funding or by volunteering time and talents.

Thank you. For what it means to Kate and what it means to all of us.


